All applications are considered against our Authorised Purposes for racing and amateur sports and eligibility criteria. For amateur sports, registration with the New Zealand Charities Commission or being an Incorporated Society and playing a sport recognised by Sport New Zealand is a minimum requirement. The New Zealand Racing Board is committed to ensuring our processes comply with our obligations under the Gambling Act 2003.
